# **Attendance and Driving Privileges**

Remember to notify your students about Attendance and Driving Privileges. Schools are usually closed over the summer; therefore, it is challenging for students to have their driver's license reinstated during that time.

The Florida Legislature requires schools to report to the Department of Highway Safety and Motor Vehicles (DHSMV) the name, birth date, sex and social security number of any minor who attains the age of 14 and accumulates 15 unexcused absences in a 90-calendar-day period. The legislation states that minors who fail to satisfy attendance requirements are ineligible for driving privileges. School districts must report all students who withdraw from school with a withdrawal code, calculated in the dropout rate, to DHSMV.

According to section <u>322.091</u>, Florida Statutes (F.S.), a minor is not eligible for driving privileges unless he or she:

- Is enrolled in a public school, nonpublic school or home education program and satisfies relevant attendance requirements;
- Has received a high school diploma, high school equivalency diploma, special diploma or certificate of high school completion.
- Is enrolled in a study course in preparation for the high school equivalency assessment and meets relevant attendance requirements.
- Is enrolled in other educational activities approved by the school board that satisfy relevant attendance requirements.
- Has been issued a certificate of exemption according to s. <u>1003.21(3)</u>, F.S.

Has received a hardship waiver, pursuant to s. <u>322.091</u>, F.S.

Because schools are closed during the summer months for most students, schools and districts can help by reminding students before the last month of the school year so they are aware of their attendance status. This will allow students the opportunity to improve their attendance before their information is sent to DHSMV.

# Attendance and Driving Privileges (cont'd)

# THE SCHOOL'S RESPONSIBILITIES

- The principal or designee is responsible for notifying the district school board of all students between the ages of 14 and 18 who accumulate 15 unexcused absences within a period of 90 calendar days. This may look different depending on your county school district.
- O Typically, the data prep or the person responsible for recording attendance will send a report to the district data school office.



- The district-level data office will then electronically transmit the name of the student, date of birth, gender and, if available, social security number to the Northwest Datacenter, which then sends the information to DHSMV.
- The school district is also required to report all students who withdraw from school with a withdrawal code that is calculated in the dropout rate.
- The DHSMV will not process records of students who are less than 14 years of age. Notification to the DHSMV initiates one of two actions:
  - The DHSMV will post a Notice of Intent to suspend driving privileges to the driving record of all reported licensed students. These students may lose their driver's license unless they comply with attendance requirements; or
  - The DHSMV will post an education noncompliance entry to the record created for this specific purpose for all reported unlicensed students, and they may not apply for a driver's license until relevant attendance requirements are satisfied.

# Certification

## RESTRICTED PROFESSIONAL CERTIFICATE

Rule <u>6A-4.004</u>, Florida Administrative Code (F.A.C.), Florida Educator's Certificates with Academic, Administrative, Degreed Career and Technical, and Specialty Class Coverages.

(6) Restricted professional certificate.

(a) A restricted professional certificate is a renewable type of certificate valid for five (5) school years issued by the Department of Education to an applicant who meets the following eligibility requirements:

- 1. Completes the application requirements as specified in Rule <u>6A-4.0012</u>, F.A.C.; and
- Satisifes all eligibility criteria specified in s. <u>1012.56(2)</u>, F.S., except for mastery of general knowledge per s. <u>1012.56(3)</u>, F.S.
- 3. A restricted professional certificate is only available to instructional personnel who are not classroom teachers, as defined in s. <u>1012.01(2)</u>, F.S., in the following subject areas:
  - a. Educational Media Specialist;
  - b. School Counseling;
  - c. School Psychologist;
  - d. School Social Work; or
  - e. Speech-Language Impaired.

(b) An applicant who meets these requirements must only be assigned to non-classroom instructional positions for which they are certified.

#### NON-CERTIFICATED INSTRUCTIONAL PERSONNEL

## Rule 6A-1.0502, F.A.C.

School social workers can also hold licenses issued by the Department of Health without having to hold an educator certificate. However, it is at the discretion of the employer to determine the employment requirements. Rule 6A-1.0502(12), F.A.C., notwithstanding the provisions of subsections 6A-1.0502(1) through (9), F.A.C., the school board or charter school governing board may employ persons licensed as clinical social workers under Chapter 491, F.S., to render services to students in those areas covered by such license. The procedures for employment shall be the same as provided by law for certificated instructional personnel, and each person so employed shall be entitled to a written contract in the form prescribed pursuant to Rule 6A-1.064, F.A.C., provided, however, that a non-certificated person employed to render services as a licensed clinical social worker may not be assigned duties of an instructional nature that are not

covered within the scope of the person's license as defined by law.

Jointly published by the National Center on Educational Outcomes and the Time Instructional Engagement Support Center, a brief titled <u>MTSS for All: Including</u> <u>Students with the Most Significant Cognitive Disabilities</u> provides suggestions for ways in which MTSS can include students with the most significant cognitive disabilities so that the MTSS provides a whole school and whole district approach to be implemented by educators.
